

## **NOTICE TO AIR CARRIERS FEES FOR THE GRANTING OF TRAFFIC RIGHTS**

(courtesy translation)

### **NON SCHEDULED SERVICES**

Non Scheduled services operated by both EU carriers and Third Countries air carriers through extra-European routes to/from Italy, are subject to the prior authorization issued by ENAC - Department of Air Transportation and Licensing.

The new ENAC Regulation for Tariffs, Ed. 3, Rev. 0, dated 27 September 2024, introduces the payment of a fixed fee for the issue of seasonal authorisations relating to traffic rights in favour of carriers operating scheduled air services (art. 17, paragraph 3).

#### **Art. 17: Flight permits and flight authorizations**

3. For seasonal authorisations issued on traffic rights, related to commercial flights, a fixed fee of € 110 per single schedule and charter authorisation is payable.

Seasonal authorizations issued on traffic rights with reference to charter air services are those that consist of a series of flights carried out in the same IATA traffic season\*.

The following are therefore excluded:

- air taxi services (operated with aircraft certified for a maximum number of passengers of less than 20 seats);
- single charter flights.

\* [In the case of multiple split requests relating to the same series of flights, only one authorization per season will be subject to a fee].

Consequently, the carrier interested in obtaining a seasonal authorisation shall:

- 1) log in the "Online Services" available on the website [www.enac.gov.it](http://www.enac.gov.it) (top right);
- 2) go to "Web Services" and register (follow the instructions for national or foreign users);
- 3) once you have registered and logged in to the portal, select 'Personal Area' and link the airline to your profile;
- 4) click on "new request" → "online payments";
- 5) select payment code 17-5 and proceed with the payment of the total amount of €146 (pursuant to Art. 17 + Art. 7 expenses + stamp duty);
- 6) send the invoice automatically generated by the system, together with the request for seasonal authorization, accompanied by all documentation (operational program, insurance, charter agreement and Operator's data information), to the following addresses:
