**6. APPLICANT DECLARATION**

You are required to make the following declaration before your application can be processed.

Being aware that pursuant to articles 75 and 76 of the Italian Law 445/2000 in case of false declarations ascertained by ENAC, the penalties envisaged will be applied, signing the present application I, on behalf of the operator, **DECLARE** that:

- 1) Copy of documents listed in section 4 related to the aircraft listed in section 3 are valid
- 2) Flight are conducted by pilots holding the appropriate licenses and type rating issued in accordance with the ICAO standards
- 3) Aircraft will be operated in accordance with the limitations/conditions established in the Manuals and further limitations attached to the Airworthiness Certificate
- 4) Aircraft has the required equipment installed in order to operate in the aerial spaces for which the authorization is requested
- 5) Manufacture's maintenance program is satisfied, except waives expressly granted by the Authority of the State of registry or by a maintenance organization recognized by ENAC
- 6) Flight are conducted in compliance with the Italian rules of the air and the procedures published in the national aeronautical publication (AIP and NOTAM)
- 7) Remunerated flight activity is not allowed unless authorized by ENAC
- 8) Certificate of Insurance listed in section 4 complies with Regulation (EC) 785/2004
- 9) No Weapons, Munitions and/or Dangerous Goods are carried on board of the aircraft listed in section 3

Additional limitations could be applied following the assessment of the documentation provided.
