Summary of the exemption	Regulations (EU) 2018/1142 amending the Continuing Airworthiness Regulation introduced new rules for Aircraft Maintenance Licence including a new category/subcategory to exercise maintenance privileges on Sailplanes, Powered Sailplanes, Balloons and Airships. However, the COVID-19 outbreak has resulted in drastic restrictions that may prevent regulated persons from effectively implementing these new requirements. Accordingly, this exemption allows to temporarily continuing exercising privileges based on former Article 5 of Regulation (EU) 1321/2014 that states national qualifications apply. In view of the above IT-ENAC has decided that, subject to fulfilling the applicable mitigating conditions as specified in this Exemption (see field "Summary of mitigating measures"), all of the following shall apply:

	 a) By way of derogation from Point 2(b) of Article 2 of Regulation (EU) No 2018/1142 and CAO.A.40(a) of Regulation (EU) 1321/2014, as amended, for Sailplanes, Powered Sailplanes and Balloons, the requirement for certifying staff to be qualified in accordance with Annex III (Part-66) laid down in point M.A.606(g) of Annex I (Part-M), in point CAO.A.40(a) of Annex Vd (Part-CAO) and in point 145.A.30(g) and (h) of Annex II (Part-145) shall apply from 1 February 2021; b) Certifying staff employed by organisations involved in the maintenance of Sailplanes, Powered Sailplanes, Balloons have permission to continue to Release to Service such aircrafts holding CIT (Certificato di Idoneità Tecnica) as national qualification issued in accordance with Regolamento Tecnico ENAC Quarto/41/B until 31 January 2021. 		
Reasons for granting it	Urgent unforseeable circumstances	The COVID-19 outbreak has resulted in drastic restrictions, which may prevent the proper implementation of the revised Annexes to Regulation (EU) No 1321/2014 amended by Regulations (EU) 2018/1142, and applicable as of 1 October 2020.	
	Urgent operational needs	As a result of the of the extreme operational and resource constraints caused by the COVID-19 outbreak, it is needed to apply this exemption to ensure business continuity, when the said circumstances are notified to the Competent Authoirty by the person or organisation involved in the continuing airworthiness including maintenance of aircraft different from airplanes and helicopters.	
Summary of mitigating measures	Safety, environmental protection	 Safety : Certifying Staff employed by maintenance oraganisations shall hold national qualification issued in accordance with Regolamento Tecnico ENAC Quarto/41/B (Certificato di Idoneità Tecnica).
